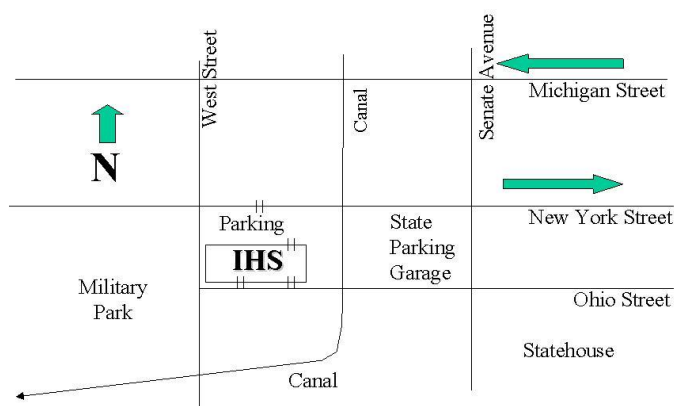

## **In Memoriam**

**Rozann Rothman**, an active LWV member here in the 1980s and 1990s, died in early January after a long illness. Rozann served several terms on the local LWV Board of Directors, taught at IUPUI, and worked as a lobbyist for several social service groups.

**Marcella Egenes**, an active elder member of LWV-Indy in the 1980s and 1990s, died last fall. A former teacher and Women's Army Corps (WAC) member, Marcella earned a social work from Indiana State following the Korean Conflict and worked afterward in the Indianapolis Public Schools. She moved several years ago to Arkansas, to live near a sister. Marcella died in Hot Springs Village on 21 November 2010.

# *LWV-Indianapolis Updates*

## **Sidewalk Maintenance: What Leaguers Can Do**



Earlier in March the Greater Allisonville Community Council invited Department of Public Works (DPW) representatives to speak about roads and sidewalks. They specifically spoke about the repairs that can be made with revenues from the sale of the city's water and wastewater systems to Citizens Energy. My neighborhood sidewalks need attention. Now that the weather is warmer I will take a few walks around the neighborhood to identify the problem areas and report to my civic association and then to DPW. LWV members can survey their own neighborhood and/or report any sidewalk that is crumbling, heaving, or needs handicap ramps. Sidewalks should be four feet wide. ## **LWV Publications: Distribute! Distribute! Distribute!**

Need to know how to contact your state senator or representative? How about who your local township trustee or school board member is? Never fear, the *DGO* is here! The League's *Directory of Government Officials* is hot off the presses and ready for distribution. Please pick up a stack at the next LWV function you attend and pass them out to friends, neighbors, and family. Distributing the *DGO* is an easy but important form of League service all of us can do!

The *Unigov Handbook* is also nearing completion. The initial design work has been completed and it is undergoing content revision due some local government reform legislation that is still pending in the General Assembly. We are printing 1,000 copies and your help is needed to distribute them around the city later this summer. The *Unigov Handbook* is the preeminent publication of our League. We have been told by city officials that they use it regularly and last year former Mayor Bill Hudnut contacted the League asking for a copy. ## **Indiana Council for Women “Listening Session”**

On March 22 the LWV sponsored a “listening session” by the Indiana Council for Women at the College Avenue Branch Library. These sessions will occur statewide and are being conducted to help the Commission prioritize the issues impacting Hoosier women so they can create an action plan.

Around 20 women representing a variety of ethnicities, ages, and sexual orientation joined for an energizing conversation. As a large group, participants were asked to brainstorm the different challenges and barriers women face. Responses ranged from access to childcare to unemployment, pay equity, transportation, work flexibility, and racial and gender discrimination. After a vote, the top three priorities that emerged were: (1) Access to reproductive health care, (2) Domestic Violence, and (3) Access to (early childhood & family) education. Participants were asked to choose the issue that interested them the most and in a small group discuss a series of questions before recommending an action plan. Erin Kelley participated in the small group discussion on access to reproductive health care while Coy Halpern participated in the access to education group.

The reproductive health care group defined “access” by relating it to transportation, number of clinics/doctors in a community, cost, and medically accurate information. To help create a balance between religion and policy, the group thought an honest conversation amongst women’s organizations on how they define “reproductive health care” (which to the small group meant more than abortion) and why the topic matters to women’s economic well being is an important future step.

The group that focused on access to early childhood and family education stressed the importance of using data to talk with legislators and other officials regarding the long term benefits (both economically and socially) of early childhood education. They suggested that the best practices of other states be examined and used in any future decision-making.

## **LWV Transit Liaison**

The LWV of Indianapolis is looking for volunteers willing to serve as liaisons to a coalition of transit advocates spearheaded by the Central Indiana Regional Transit Authority (CIRTA, [www.cirta.us](http://www.cirta.us)). More specifically, CIRTA is trying to build a coalition that will support a resolution asking the 2012 Indiana General Assembly to enact legislation that enables local governments to conduct referenda creating revenue dedicated to transit and transportation alternatives.

Our “urban region” and “downtown development” positions endorse the use of public money to support transit initiatives. The grey area is whether we support the use of referenda, either in general or for a specific case like this one. This issue will be brought up at the annual meeting and the executive director of CIRTA, Ehren Bingaman, will be our May 20 Lunch with LWV speaker.
